



Pet Policy Agreement

(Does not apply to service animals assisting disabled persons)

1. Pet Fee

A non-refundable pet fee of **\$50.00/ stay** will be charged to your account prior to check-out to cover the cost of additional and necessary cleaning required for pet occupied cabins.

2. Acceptable Pets

Point Lookout welcomes all well-mannered dogs that are non aggressive in nature. **Aggressive animals are not permitted on property.**

We reserve the right to require immediate removal of any pet that displays dangerous or unacceptable behavior, including, but not limited to, biting, excessive noise (such as barking), evidence of disease, or urination / defecation in public areas. **No more than two (2) pets may occupy a cabin.** Each guest is responsible for all charges that relate to the removal of his / her pet, including but not limited to transportation and kennel charges. **I understand I may also have to reimburse the Resort for refunds to other guests inconvenienced by my pet.** Pet owner should provide pet food/water bowls and bedding. All pets must display current rabies vaccination tag.

3. Pet-Friendly Walking Areas

Pets are welcome on the walking trails on the mountain but must be leashed at all times. Please properly dispose of pet waste.

4. Pet Control / Containment in Public Areas.

Pets must be leashed and firmly held when they are in all public areas of the Resort property including walking trails on the mountain. Pets are not permitted in public areas of the Resort such as: meeting space facilities, indoor dining areas, indoor recreational areas, soccer field, or tennis courts. **Pets that are not housebroken may not be left unattended.**

5. Housekeeping

For the safety and comfort of your pet, Housekeeping will enter your cabin only if: (a) your pet is not present, or (b) you are present and can monitor your pet. On extended stays, Housekeeping service is required at a minimum of every 3 days.

6. Damage to Guest Rooms and Public Areas

Your account will be charged for the repair /replacement cost for any damage caused by your pet including excessive cleaning over and above the normal wear & tear of a well behaved and supervised pet.

I am aware that I will be held responsible for any damages or extraordinary cleaning costs my pet may cause. If any damages are incurred, the appropriate charges will be paid either prior to departure or delayed billed to the credit card on file after check out.

I understand, the Resort may ask me to check-out if any of the pet policies stipulated above are violated. As a consequence of any violation, I will forfeit that night's room charge. I will supply a cell phone # to the front desk to be contacted during my stay if necessary.

I agree to the above guidelines and understand that I must abide with each as written.
